It is understood that the headstone is to be made according to City of Colton Hermosa Gardens Cemetery regulations and that if it is not properly made to the specification it will be refused. It is also understood and agreed that City of Colton Hermosa Cemetery and its assigns is not guaranteeing the quality or the integrity of the outside headstone vendor company product. With the purchase and request of placement of the outside headstone, the owner, heirs and purchaser agree to indemnify, defend against and hold harmless City of Colton, Hermosa Gardens Cemetery and its affiliates, assigns and agents from any and all claims which are related to the purchase, placement, damage or vandalism of the headstone.

The setting fee of \$_____ must be made prior to the installation of the headstone.

The headstone is to be delivered into Hermosa Gardens Cemetery's care in which the cemetery staff will coordinate installation in a timely manner within two weeks of delivery.

NOTE the FOLLOWING RESTRICTIONS and REQUIREMENTS:

- All headstones must be solid granite.
- All headstones must be approved prior to delivery, acceptance and installation-regardless of the source of purchase.
- Authorization must be signed and dated by the property owner and purchaser prior to installation-regardless of the source of purchase.
- The setting fee must be paid prior to delivery.
- Only Hermosa Staff may install headstones on Hermosa Gardens Cemetery property.
- Hermosa is not responsible for cost loss for rejected headstones that are not consistent with requirements.
- Delivery is Monday through Friday 7:00 am – 3:30 pm with 48h prior delivery notification including delivery window of time.
