- Qualifications for appointment to these bodies are:**
(Municipal Code Section 2.30.060)
- 1 Be a resident of the City of Colton. No individual may serve concurrently on more than one City Commission or Committee. (Section A)
 - 2 Be a Business Owner of a Business within the City of Colton. Such appointments shall be limited to two members per Commission or Committee. (Section E)
 - 3 No former elected official of the City is eligible for appointment to any Commission or Committee for two years following the expiration of the term of his or her elected office. (Section B)
 - 4 No Current employee of the City is eligible for appointment to any Commission or Committee. (Section C)
 - 5 No person related to a member of the current City Council is eligible for appointment to any Commission or Committee. (Section D)
